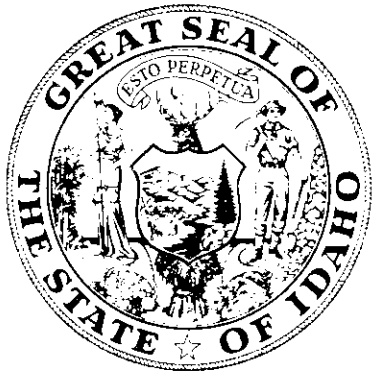

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
MAGIC MILLS, INC.

Pursuant to the provisions of the Idaho Business Corporation law, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the corporation is MAGIC MILLS, INC.

ARTICLE II

The following amendment of the Articles of Incorporation was adopted by the Stockholders of the corporation on the 28th day of April, 1980, in the manner prescribed by I.C. Sec. 30-146:

Article I of the Articles of Incorporation is hereby deleted and replaced with the following provision;

"The name of the corporation is KUEST ENTERPRISES, INC."

Article IV of the Articles of Incorporation is hereby deleted and replaced with the following provision;

"The location and post office address of the registered office of the corporation is Box 110, Filer, Idaho 83328. The registered agent is Johnnie Kuest with the same address."

ARTICLE III

The number of shares of the corporation outstanding at the time of such adoption was 400; and the number of shares entitled to vote thereon was 400.

ARTICLE IV

All outstanding shares were entitled to vote thereon and were common stock.

ARTICLE V

The number of shares voted for such amendment was 400; and the number of shares voted against such amendment was zero.
