ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE STATE OF IDAHO

The undersigned, acting as the incorporator of a nonprofit corporation, under the provisions of I.C. 30-3, the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME

The name of the corporation shall be: SOUTH LAKE YOUTH MINISTRIES, INC.

ARTICLE II.

DURATION

The duration of the corporation shall be perpetual.

ARTICLE III.

PURPOSE

The corporation is organized exclusively for charitable, educational, and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Code. Consistent with and subject to its qualification under Section 501(c)(3) of the Internal Revenue Code, the purposes for which the corporation is formed are as follows:

- 1. To form youth groups that will teach how to live out Godly lives, train teens and college students in biblical truth, encourage mature adults to invest in the next generation, create opportunities for positive interaction between adults and youth, and to provide training and resources to those adults in order to facilitate effective, lasting youth ministries; and
- 2. To engage in any activity which may lawfully be conducted by a corporation organized under I.C. 30-3, the Idaho Nonprofit Corporation Act.

ARTICLE IV.

SECTION 501(c)(3) RESTRICTION

The corporation shall have all the powers granted by law necessary and proper to carry out its above-stated purposes. However, the powers of the corporation shall be limited to those permitted to an organization which is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law, nor shall the corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law, carry on any activities which would remove the said tax benefits.

ARTICLE V.

MEMBERSHIP

The corporation shall have no members.

ARTICLE VI.

REGISTERED AGENT AND OFFICE

ARTICLE VII.

BYLAWS

Provisions for the regulation of the internal affairs of the corporation shall be set forth in the Bylaws, subject to the

provisions of these Articles. If no Bylaws exist, the internal affairs of the corporation shall be as set forth in the Idaho Nonprofit Corporations Act, subject to the provisions of these Articles.

The authority to make Bylaws for the corporation is hereby vested in the Board of Directors and they may change and amend such Bylaws so long as they do not conflict with the provisions of these Articles or with the regulatory agreement.

ARTICLE VIII.

organization or organizations selected by the directors which is qualified as exempt under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986, or any successor statute and regulations thereof, as presently existing or as may be hereafter amended.
