ARTICLES OF INCORPORATION  
OF  
SHEPHERD OF THE VALLEY LUTHERAN CHURCH, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all being of legal age and citizens of the United States, have associated ourselves together for the purpose of forming a body corporate in accordance with the provisions of the non-profit corporation laws, 30-117A of the State of Idaho, and do hereby make, execute and acknowledge these articles in writing.

ARTICLE I.

The corporate name of this association shall be: Shepherd of the Valley Lutheran Church, Inc.

ARTICLE II.

This association shall have perpetual existence.

ARTICLE III.

The purposes for which said association is formed are those set forth in the document entitled "Constitution", a copy of which is attached hereto and incorporated herein as set forth in full.

ARTICLE IV.

The affairs of the association shall be under the control of not less than three (3) directors, and those, who shall as directors, manage the affairs of the association for the first year and until their successors are duly elected and qualified, are:

At the first annual meeting following the expiration of the one year period for which the directors herein designated will serve, and at each annual meeting thereafter, a new Board of Directors will be elected in accordance with the provisions of the by-laws of the association and the laws of the State of Idaho, in such cases made and provided.

ARTICLE V.

In the event of the liquidation or dissolution of the corporation, the assets of the corporation, after the payment of all debts and obligations, shall be given to the American Lutheran Church, of which this corporation is a member.

ARTICLE VI.

The address of the initial registered office shall be 10867 Onondago, Boise, Idaho 83705, and the name of the initial registered agent for the service of process is Reverend John Reitan.

ARTICLE VII.

This association shall have no capital stock. Membership in the association shall be evidenced as provided in the By-laws of the association.

ARTICLE VIII.

The By-laws of the association for the management of its affairs shall be adopted by the members of said association, and said members will be empowered to amend or repeal said By-laws in accordance with the provisions thereof.

ARTICLE IX.

Cumulative voting shall not be allowed.
