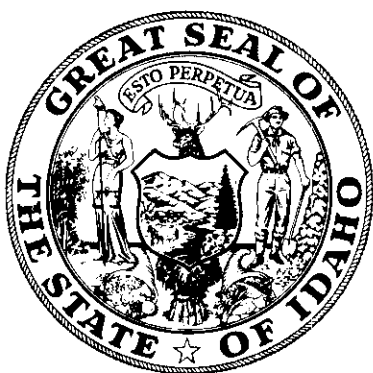

ARTICLES OF INCORPORATION

OF

HOMEDALE LIONS CLUB, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is HOMEDALE LIONS CLUB, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Non-Profit Corporation Act, including but not limited to social and civic purposes.

FOURTH: The aggregate number of certificates which the corporation shall have authority to issue is 100 certificates of membership all of one class.

FIFTH: The address of the initial registered office of the corporation is Route # 1 Box 1140, Homedale, Idaho 83628, and the name of its initial registered agent at such address is ALAN JOHNSTONE, Route # 1 Box 1140, Homedale, Idaho 83628.




