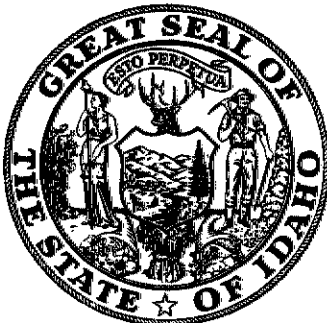

That we, the undersigned are citizens of the United States, of whom are residents of the State of Idaho, and desiring to form a non-profit corporation under Article 30-3-20 of the Idaho Code, do hereby certify:

FIRST: That the corporate name of this Association shall be Felicia's Subdivision Homeowners Association, Incorporated. This Association is applying for a Non-Profit corporate status. The object for which it is formed as to the purpose of this Non-Profit Corporation is to collect monies and or disburse monies regarding the managing and governing of the Felicia Subdivision common areas, which is defined by its legal description. This corporation will carry on any business that may come before it. And, in general this corporation is set forth to carry out the Covenants, Conditions and Restrictions regarding Felicia's Subdivision Homeowners Association, Incorporated.
