**Articles of Incorporation  
Forerunner Evangelistic Ministries, Inc.  
Idaho Falls, Idaho**

**Article I**

**The name of the corporation shall be Forerunner Evangelistic Ministries, Inc.**

**Article II**

**This corporation is a non-profit corporation.**

**Article III**

**The term for which this corporation shall exist is perpetual.**

**Article IV**

**The location and post office address of the registered office of this corporation shall be 465 12<sup>th</sup> St, Idaho Falls, Idaho, 83404, and its registered agent at such office shall be Colan T. Deatherage.**

**Article V**

**The purposes for which the corporation is organized are as follows:**

- 1. To bring all men into a personal relationship with the Lord Jesus Christ as their Savior, and to exercise any means not inconsistent with the laws of God or men to accomplish the said purpose.**
- 2. To provide the local churches with evangelists whose faith, practice and purpose are consistent with those of the corporation.**
- 3. To provide service opportunities in local churches to evangelists whose faith, practice and purpose are consistent with those of the corporation.**
- 4. To promote the well-being of local churches through the conducting of revival services and evangelistic training, preparing, enabling and assisting the local church to carry out the Great Commission.**
- 5. To provide a fellowship for evangelists whose faith purpose and practice are consistent with those of the corporation.**
- 6. To receive gifts and grants of money and property of every kind and to administer the same for religious, evangelistic, charitable, educational, and civic purposes.**
- 7. To own real estate, in the furtherance of the purposes herein stated; to improve the same and to construct evangelistic and educational buildings, camp and retreat facilities, or community**

9. To do any and all other things necessary in furtherance of the purposes stated, not inconsistent with the corporation laws of the state of Idaho.
10. In the event that this corporation is dissolved, the assets, after payment of obligations, shall be distributed to religious organizations or individuals holding the same faith and purpose, as determined by the board of directors.

#### **Article VI**

The management and business affairs of the corporation shall be conducted by a board of directors. The board of directors, consistent with the laws of the ste of Idaho, Title 30, Chapter 3, Section 65, shall be:

#### **Article VII**

The Board of Directors of this corporation may meet and transact the business hereof either at the principal place of business, or at such other place as may be designated by resolution of the Board of Directors.

#### **Article VIII**

The bylaws of this corporation may be repeated, amended, altered, or new bylaws adopted at any annual meeting, or at a special meeting of the members called for that purpose, by a vote representing three-quarters of the members of the corporation.

#### **Article IX**

This corporation is formed without capital stock. The corporation is to have membership. Members will include all employees of the corporation, which will be employed subject to provisions contained in the Articles of Faith and the bylaws of the corporation.

#### **Article X**

The membership shall be given written notice of the organizational meeting seven days prior to the date of the meeting, and all other business meetings at least thirty days prior to the date of said meeting.
