ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, natural persons of full age and citizens of the United States of America, and citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho.

AND WE HEREBY CERTIFY:

Article 1.

That the name of the corporation shall be the SHELLEY CHAMBER OF COMMERCE, INC., with its principal place of business in the City of Shelley, County of Bingham, State of Idaho, with its initial registered office as follows:

SHELLEY CHAMBER OF COMMERCE, INC. 152 South State Street Shelley, Idaho 83274

Article 2.

That the purposes for which said corporation is formed are:

- (a) To promote and encourage the advancement of the civic, commercial, industrial and agricultural interests of the City of Shelley and surrounding territory.
- (b) To promote the general welfare and prosperity of the City of Shelley, Bingham County and surrounding territory.
- (c) To sponsor all projects that will improve and develop and enlarge the City of Shelley and surrounding territory and make it a better place in which to live, including such civic, educational, and social features and programs as will bring about these objectives.

Aritcle 3.

This organization in all its activities shall be non-partisan, non-sectional and non-sectarian, and shall not by resolution or vote be committed to the support or

Article 9.

The corporation shall have one class of members which class shall be designated "members", and any person, firm, partnership, association, or corporation shall be entitled to membership in the corporation who shall pay the annual dues fixed by The Board of Directors. All members possess the same rights and qualifications. Termination of membership for non-payment of dues shall be provided in the by-laws of the corporation.

Article 10.

The members of the corporation shall have the right to adopt, amend or repeal such by-laws as may be required for the management of the affairs of the corporation by a majority vote at any regular meeting. The Articles of Incorporation may be amended by a vote of two-thirds of the members in good standing in attendance at a regular meeting, or at any special meeting called for such purpose, provided that such proposed amendment or amendments shall be plainly stated in the call for the regular or special meeting at which they are to be considered.

#### Article 4.

The corporation shall have the right to acquire, take by gift, purchase, devise or bequest, real and personal property for all purposes covenient and appropriate in the exercise of powers, or necessary or convenient to carry out the above objects, and, incidental to said objects, and shall have the right to lease, mortgage and dispose of real and personal property, including the right to take, hold and dispose of shares of stock in other corporations.

#### Article 5.

Pecuniary profit to the corporation or its memebers is not the object of this corporation and no pecuniary gain or profit is contemplated; and the private property of the members of this corporation shall not be liable for the debts and obligations thereof, but shall be wholly exempt therefrom.

#### Article 6.

That the term for which said corporation is to exist is perpetual existence, unless sooner dissolved by three-fourths of all its members voting at a meeting called for such purpose.

## Article 7.

The government of the corporation shall be vested in the Board of Directors, who shall be members of the corporation, together with such officers and committees as the Board of Directors may appoint, in conformity with these articles and with the by-laws. The Board of Directors shall consist of at least Nine (9) members who shall be nominated and elected in the manner provided in the by-laws of the corporation.

### Article 8.

The annual meeting of the members of the corporation shall be held on the last Friday in January of each year, the hour and place to be fixed by the Board of Directors.
