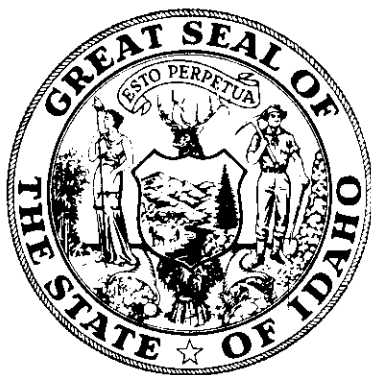

ARTICLES OF AMENDMENT

1. Name. Cook Agricultural Enterprises, Inc. was incorporated by filing the Articles of Incorporation in the office of the Idaho Secretary of State on May 29, 1986.

2. Classes of Stock. The corporation is authorized to issue only one class of stock, "common stock".

3. Shareholder Approval. At a meeting of the shareholders of the corporation held January 5, 1987, the shareholders adopted a resolution amending the Articles of Incorporation as follows:

Article 1 of the Articles of Incorporation is amended by deleting the following: The name of the corporation is "Cook Agricultural Enterprises, Inc." and substituting in place thereof. The name of the corporation is "Rainbow, Inc."

4. Shareholder Vote. At the time of said shareholders meeting there were five hundred shares of the common stock of the corporation outstanding and entitled to vote on the resolution and no other classes of stock issued. Five hundred shares voted for the adoption of the resolution and zero voted against.

5. Board of Director Approval. At a meeting of the directors of the corporation held January 5, 1987, the directors adopted a resolution amending the Articles of Incorporation as follows:

Article 1 of the Articles of Incorporation is amended by deleting the following: the name of the corporation is "Cook Agricultural Enterprises, Inc." and substituting in place

thereof. The name of the corporation is "Rainbow, Inc."

6. Exchange of Shares. The five hundred shares outstanding of the corporation shall be exchanged for five hundred shares of the common stock of the corporation bearing the name Rainbow, Inc. upon presentation of the Secretary.

7. Stated Capital. No change is made in the stated capital of the corporation.

8. The undersigned have caused this Articles of Amendment to be executed and duplicated pursuant to the resolution of the Board of Directors and the stockholder of the corporation.

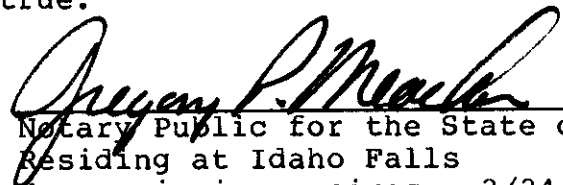
