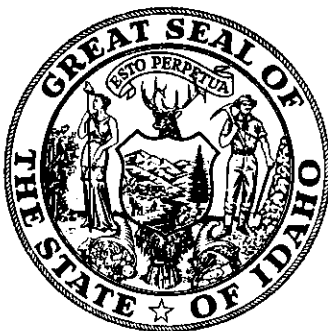
### CERTIFICATE OF DISSOLUTION OF

### ARTICLE VI

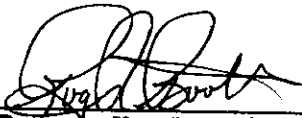
There are no suits pending against the corporation in any court.

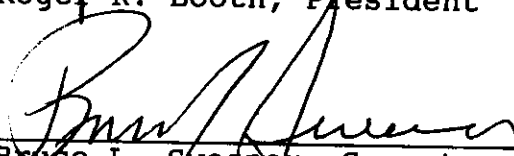
### ARTICLE VII

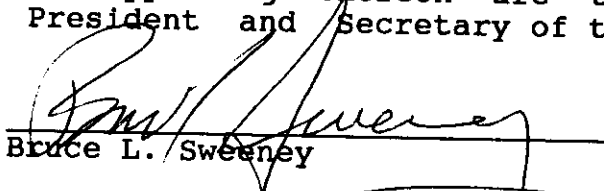

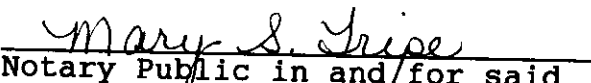
