ARTICLES OF INCORPORATION

OF

F. W. KAUPHUSMAN, INC.

KNOW ALL MEN BY THESE PRESENTS:

WE, THE UNDERSIGNED, BEING THREE OR MORE NATURAL PERSONS OF FULL AGE, ALL OF WHOM ARE CITIZENS OF THE UNITED STATES OR ITS TERRITORIES OR POSSESSIONS, HEREBY ASSOCIATE CURSELVES TOGETHER FOR THE FURPOSE OF FORMING A PRIVATE CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO AND DO HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION.

T

The name of this corporation shall be:

F. W. KAUPHUSMAN, INC.

II

The term of existence of this corporation shall be perpetual.

III

The registered office of this corporation in the State of Idaho, shall be located in the City of Boise, County of Ada, State of Idaho, and the post office address of such registered office shall be Boise, County of Ada, State of Idaho.

IV

The total authorized stock of this corporation shall be divided into one hundred (100) shares, which shall be common stock and which shall be issued with a par value of One hundred Dollars (\$100) per share. The shares of stock with or without nominal or par value may be increased and sold from time to time by the corporation for such consideration and upon such terms as may from time to time be fixed by the Board of Directors, without action by the shareholders. Such units shall be non-assessable and shall have equal voting rights and other powers.

V

The Board of Directors of this corporation shall consist of at least three (3) members and not more than seven (7) members, and all of the powers of this corporation are hereby conferred upon such directors insofar as such powers may lawfully be vested in and exercised by such a Board.

This corporation hereby reserves the right to amend, alter change or repeal any provision of these Articles of Incorporation in the manner now provided, or which may hereinafter be provided by law, and all rights, privileges and powers by the Articles are so conferred, subject to this reservation.

VIT

This corporation proposes to engage in and carry on and shall have the power to engage in and carry on certain businesses and enterprises and shall have and exercise certain rights and powers as follows:

- (1) To sell, distribute at wholesale and retail, electrical supplies and appliances and the replacement parts for same, and in every other way to operate a retail and wholesale establishment, including every description of retail or wholesale activity, and to engage in such endeavor as any natural person may or could do which may be of advantageous purpose for the corporation and which can be lawfully done under the laws of the State of Idaho.
- (2) To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares, and merchandise and real and personal property of every class and description.
- (3) In furtherance, and not in limitation of the powers hereinbefore conferred upon this corporation, such corporation shall be further empowered to do all and singular any of these things; to perform any act and to engage in any enterprise or transaction which may be necessary, suitable or convenient in the exercise of any power or right herein provided for said corporation or conferred upon it by the laws of the State of Idaho, or by the principles of the common law, including and not excluding mercantile businesses, mercantile agencies, or any other businesses that the said corporation may desire to engage in which are not prohibited by law.

VIII

The amount of capital stock actually subscribed is three (3) shares, which have been subscribed at their par value, and following are the names and places of residence of each of the incorporators who have subscribed to said stock:
