## ARTICLES OF INCORPORATION OF

### Sports Specialties, Inc.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

#### ARTICLE I

The name of the corporation is Sports Specialties, Inc. (hereafter "Corporation").

#### ARTICLE II

The purpose for which this Corporation is organized are as follows:

- 1. To engage in sporting equipment sales ; and
- 2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.
