ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

THAT THE INCORPORATOR who is JIN Y. PARK does form a corporation under and pursuant to the laws of the State of Idaho, and does hereby certify as follows:

FIRST

The name of the proposed corporation is GyroTherm, Inc.

SECOND

The purposes for which this corporation is formed are as follows:

- a. Principally to engage in the business of inventing, engineering and machining and associated buying, selling, producing, manufacturing and disposing of products associated with this business.
- b. To engage in general, mechanical, electrical and other contracting associated with the principal business outlined above.
- c. In addition thereto to engage in any or all lawful business for which corporations may be organized under the Idaho law concerning business for profit corporations and which is permitted by the laws of the State of Idaho.

THIRD

This corporation shall have perpetual existence.

FOURTH

The location and post office address of the registered office of this corporation in the State of Idaho is 526 No. Hayes, Moscow, Idaho 83843 and its principal place of business shall be at the same address. The initial Director shall be the incorporator whose name and addresse is:

ARTICLES

That the capital stock of this corporation shall consist of Twenty Thousand shares of common stock having a par value of Ten Dollars (\$10.00) per share and an aggregate par value of Two Hundred Thousand Dollars (\$200,000.00).

The capital stock of this corporation shall not be divided into classes, but shall consist of only one class, that being common stock.

The By-Laws of this corporation shall prescribe the rules and regulations setting out the formalities and procedures to be followed in effecting the transfer of common stock and regulating the use of corporate property.

SIXTH

The operations of this corporation are principally to be conducted in the county of Latah, State of Idaho. The office of the corporation will be located in the City of Moscow, County of Latah, State of Idaho.

SEVENTH

The number of directors of the corporation shall be no less than one (1).
