The undersigned, who is duly licensed to practice the profession of medicine and surgery in the State of Idaho, does hereby form a professional corporation pursuant to the provisions of Idaho Code §30-1301 et seq, being the Idaho Professional Service Corporations Act, for the purpose of rendering medical and surgical services, and hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation shall be EUGENE R. TROUT, M.D., CHARTERED.

#### ARTICLE II

The purposes for which this corporation is formed are as follows:

- A. To engage in the general practice of medicine and surgery.
- To invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and to own real or personal property necessary for the rendering of professional services specified above.
- C. To do such acts and carry on such business as may be permitted by the Idaho Professional Service Corporations Act, subject to the limitations thereof.

## ARTICLE III
