Amendment I

This amendment changes the name of the organization from "Idaho Chapter of Physically-Challenged Access to the Woods, Inc.," as stated in the original articles of incorporation, to "Treasure Valley Chapter of Physically-Challenged Access to the Woods, Inc."

This amendment was adopted by a majority vote of members in the regular monthly meeting on March 10, 1992.

Amendment II

ARTICLE XIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the State of Idaho or to the City of Boise, for a public purpose related to improving outdoor recreational accessibility for the disabled community. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of Ada County, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

This amendment was adopted by a majority vote of members in the regular monthly meeting on October 13, 1992.


