ARTICLES OF INCORPORATION
OF
POCATELLO-GATE CITY ROTARY CLUB, Inc.

The undersigned, acting as incorporator of a corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is the Rotary Club of Pocatello-Gate City.

SECOND: The Rotary Club of Pocatello-Gate City is a non-profit corporation.

THIRD: The period of the corporation's duration is perpetual.

FOURTH: The territorial limits of membership in this club is Bannock County, Idaho.

FIFTH: The purpose for which the corporation is organized is to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

(1) The development of acquaintance as an opportunity for service;

(2) High ethical standards in business and professions; the recognition of worthiness of all useful occupations; and the dignifying by each Rotarian of his occupation as an opportunity to serve society;

(3) The application of the ideal of service by every Rotarian to his personal, business and community life; and

(4) The advancement of international understanding, goodwill and peace through a world fellowship of business and professional men united in the ideal of service.

SIXTH: The address of the initial registered office of the corporation is 423 East Benton Street, P.O. Box 4670, Pocatello, Idaho 83205 and the name of its initial registered agent at such address is Charles W. Clark.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is three (3), and the names and addresses of
