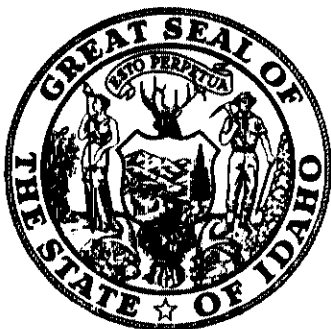
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
of  
GLOBAL EARTH SYSTEMS, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GLOBAL EARTH SYSTEMS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common capital stock with a par value of \$1.00 per share. Said shares may be issued for such consideration expressed in dollars as may be fixed from time to time by the shareholders by a vote of the holders of a majority of all shares entitled to vote thereon.

FIFTH: The address of the initial registered office of the corporation is 2773 N. Ash Park Lane, Boise, Idaho 83704, and the name of its initial registered agent at such address is Donald J. Morrison.

SIXTH: The management of the corporation shall be by the shareholders and there shall be no directors, as provided by Idaho Code, Section 30-1-35.


