SNAKE RIVER MOTORCYCLE ASSOCIATION, INC. AND AND THE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as incorporators of a non-profit corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation shall be SNAKE RIVER MOTORCYCLE ASSOCIATION, INC.

ARTICLE II

NONPROFIT CORPORATION

This corporation shall be a nonprofit corporation.

ARTICLE III

DURATION

The period of existence and duration of the life of this Corporation shall be perpetual.

ARTICLE IV

The location and address of the registered office of this Corporation in the State of Idaho shall be Rte 1 - Box 295 D, Payette, Idaho 83661. The initial registered agent at such address shall be Marshall Earl Attebery.

#### ARTICLE V

## BUSINESS, OBJECTS, PURPOSES AND POWERS

The objects and purposes for which this Corporation is formed shall be and are:

- (1) To promote the sport of motorcycling through such programs as to bring credit to the sport of motorcycling and users/owners. To help bring about fair and just legislation on motorcycling and to keep public and private lands open to recreational uses by off-road vehicles.
- (2) To purchase, own, lease, hold, improve, sell and convey such real property and to construct, lease, and maintain thereon such buildings or other improvements as shall be necessary or proper for conducting the business of this Corporation, either within or without the State of Idaho: and to buy, own, lease, improve, sell or convey such other real estate as shall be acquired by this Corporation in the conduct of its business and purposes.
- (3) To purchase, own, hold, vote, sell or hypothecate the stocks and bond of other coporations and to take in the name of this Corporation such stocks, bonds, mortgages, notes, deeds, conveyances, or other evidence of indebtedness, ownership, title, or security as may be required by this Corporation in the usual and ordinary transaction of its business and purposes.
- (4) To borrow money in the name of this Corporation in such amounts as the Board of Directors or Trustees may determine and issue as evidence thereof notes, bonds, or other evidence of indebtedness of this Corporation, and to secure the payment of the same, when required, by mortgages, trust deeds, pledges, and other conveyances of all or any portion of its property, real or personal.
- (5) To enter into any and all contracts and obligations of any type or kind essential, necessary, or proper to the transaction of its ordinary affairs and for the purposes of the Corporation.
- (6) To carry out the objects and purposes for which this Corporation is formed, as principal, agents, or otherwise, to the extent as natural persons might do.
- (7) To conduct the business of this Corporation as herein set out at any place or places within the State of Idaho or territory of the United States as the Board of Directors or Trustees may from time to time determine.

(8) It is the intention of the incorporators of this organization that the foregoing clauses shall be construed both as objects and powers, and the foregoing enumeration of specific powers shall not be construed to limit or restrict in any manner the powers of the Corporation, except as these powers are limited and restricted by Chapter 3, Title 30, Idaho Code; but that said Corporation shall have the power to do all and everything necessary, suitable, convenient, or proper for the accomplishment of any of its purposes or the attainment of any one or more of the objects herein enumerated or incidental to the powers herein named or which shall, at any time appear conducive or expedient for the protection or benefit of the Corporation and this to the same extent and as fully as natural persons might or could do.

### ARTICLE VI

# MEMBERSHIP CARDS AND MEMBERSHIP RIGHTS

This Corporation is authorized to issue Membership Cards to all persons who are interested in the objects and purposes of this Corporation, said Membership Cards not to exceed 500 in number. The Board of Directors or Trustees are authorized, as directed by the By-Laws, to require consideration, if any, for the issuance of said Membership Cards, which consideration, if any, shall be used for the purpose of carrying out the objects and purposes of this Corporation as set forth herein and governed by the By-Laws.

The rights and interest of all members shall be equal and each member shall be entitled to only one (1) Membership Card and to only one (1) vote.

## ARTICLE VIII

#### DIRECTORS OR TRUSTEES

The Corporation shall be governed by a Board of Directors or Trustees of not less than three (3) or more than twelve (12) in number as set forth in the By-Laws of the Corporation. The number of Directors constituting the initial Board of Directors shall be five.
