



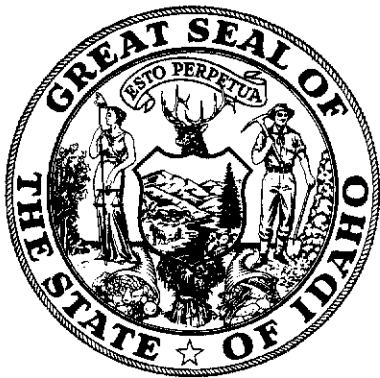
CERTIFICATE OF INCORPORATION

ARTICLE OF INCORPORATION

The undersigned, acting as incorporator of COLCO INVESTMENT COMPANY, INC. a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

- FIRST: The name of the corporation is COLCO INVESTMENT COMPANY, INC.
- SECOND: The period of its duration is perpetual.
- THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act and as such may be amended.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Fifty Thousand (50,000) shares of common stock of a par value \$1.00 per share, an aggregate total capital of Fifty Thousand and no/100 Dollars (\$50,000.00).
- FIFTH: Provisions denying preemptive rights are: There are no preemptive rights.
- SIXTH: Provisions for the regulation of the internal affairs of the corporation are: The Bylaws shall set the number of and qualification of directors and officers and shall set forth any restrictions, if any, on the transfer of shares.
- SEVENTH: The address of the initial registered office of the corporation is 1401 Sage Point, Meridian, Idaho 83642 and the name of its initial registered agent at such address is COLIN CONNELL.
- EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is as set forth in the Bylaws, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and shall qualify are:


