

## ARTICLES OF INCORPORATION. of the

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntairly associated ourselves together for the purpose of forming a corporation, under the laws of the state of Idaho.
And WE HEREBY CERTIFY;

FIRST. That the name of the said Corporation is, SUGAR CITY BUILDING AND MANUFACTURING COMPANY.

SECOND, That the purposes for which it is formed, are to do a general contracting business; to own and operate saw mills; plan-ing mills; to buy, to sell and to lease real estate, building, shops or residences; to buy and sell lumber, hardware and all building material; to manufacture articles of wood, brick and cement blocks; to own and operate stone quarries, lime kilns and power plants.

THIRD, That the capital stock shell be \$10,000.00 divided into

1000 shares of \$10.00 each
FOURTH, That the place where its principal business is to be transacted shall be Sugar City, Fremont County, Idaho.
FIFTH, That the term for which it is to exist is twenty-five

years from and after the date of its Incorporation.

SIMTH, That the number of its directors shall be five; that the names and residences of those who are appointed for the first year are: F. Salzner, W. J. Anderson, A. I. Comstock, W. L. Webb, all of Sugar City, Fremont County, Idaho; and Thomas Webb of Lehi, Utah County, Wish.
