CERTIFICATE OF INCORPORATION

I, FRANKLIN GIRARD, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

NEWS-REVIEW PUBLISHING CO., INC.

was filed in the office of the Secretary of State on the **nineteenth** day of **April** **A. D. One Thousand Nine Hundred Thirty-** **five** and duly recorded in Book A- 28 of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 29-103, Idaho Code, Annotated.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for perpetual existence from the date hereof, with its registered office in this State located at

Moscow in the County of Latah .

ARTICLES OF INCORPORATION

OF

NEWS-REVIEW PUBLISHING CO., INC.

KNOW ALL MEN BY THESE PRESENTS:-

That we, Pearl B. Robinson of Moscow, Latah County, Idaho, Frank B. Robinson of Moscow, Latah County, Idaho, and W. T. Marineau of Moscow, Latah County, Idaho, all being citizens of the United States and of the State of Idaho do hereby associate ourselves together for the purpose of forming a private corporation under and by virtue of the corporation laws of the State of Idaho and do hereby adopt the following articles of incorporation:

Article I.

The name of this corporation by which it shall be known and under which it shall act shall be NEWS-REVIEW PUBLISHING CO., Inc.

Article II.

The duration of this corporation shall be perpetual.

Article III.

The location and post office address of the registered office of said corporation in the State of Idaho shall be Moscow, Latah County, State of Idaho.

Article IV.

The total number of par value shares of the capital stock of said corporation shall be 250, and their aggregate value shall be Twenty-five thousand Dollars (\$25,000.00) and that said stock, when fully paid, shall be non-assessable.

Article V.

The enterprise, business, pursuits, occupations, and purposes for which this corporation is formed and in which it proposes to engage are to acquire, deal in, handle, own, purchase, sell, mortgage, hypothecate, or

otherwise handle real and personal property necessary in the conduct of the business of said corporation, and in said connection to build, purchase, lease, own, or otherwise acquire buildings, offices, workshops, plants, and all kinds of personal property necessary or useful for the purpose of carrying out the objects of this corporation; to carry on generally the business of printing, publishing and distributing newspapers, pamphlets, books and other documents and all classes and kinds of printing and publication; in that connection to bind and otherwise manufacture or treat any books, pamphlets, or other printed material and to conduct generally the business of a printing and publishing establishment.

To buy, own, lease, control, operate, mortgage and sell or make other disposition of radio stations and to do all things necessary or desirable to be done in the operation, management and control of the same, either for personal purposes or commercial use. To enter into contracts of all kinds, with radio broadcasting systems, and with news gathering agencies of every kind and nature.

To guarantee, purchase, hold, own, vote, sell, assign, transfer, mortgage, pledge, or otherwise dispose of shares of the capital stock of any other corporation or corporations (or any bonds, securities or evidences of indebtedness created by any other corporation or corporations) organized under the laws of this state, or any other state, country, nation or government and while the owner thereof to exercise all the rights, powers and privileges of ownership.

To issue bonds, debentures, or obligations of and on the credit of this corporation from time to time for any of the objects or purposes of the corporation and to secure the same by mortgage, pledge, deed of trust, or otherwise;

To have one or more offices to carry on all or any of its operations and business, without restriction or limit as to amount, to purchase, or otherwise acquire, hold, own, mortgage, sell, convey, or otherwise dispose of real and personal property of every class and description in any of the states, districts, territories or colonies of the United

States and in any and all foreign countries, subject to the laws of such state, district, territory, colony or country;

The foregoing clauses shall be construed both as objects and powers and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

Article VI.

The number of directors of said corporation shall be three, and the following persons are named as directors of said corporation to serve until the first meeting of stockholders for the purpose of electing directors:

W. T. Marineau, Moscow, Idaho
