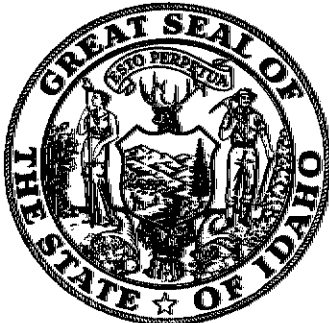

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION

OF

INTERSTATE COLLISION REPAIR, INC.
SUPPLY

The following amendment to the Articles of Incorporation of Idaho Collision Repair, Inc., an Idaho corporation whose Articles of Incorporation were originally filed in the office of the Secretary of State on _____ was duly adopted at a special meeting of the shareholders of said corporation duly held in accordance with Idaho Code Section 30-1-59.

Pursuant to Idaho Code Section 30-1-61, the undersigned President and Secretary of the corporation state:

(a) The name of the corporation is Interstate Collision Supply, Inc.

(b) The amendment adopted is to delete Article First of the Articles of Incorporation and substitute the following therefor:

First: The name of this corporation shall be GERCAR Corp.

(c) The shareholders adopted this amendment at a special shareholders' meeting duly held on May 22, 1995.

(d) The number of shares of capital stock of the corporation issued and outstanding at the time of such shareholders' meeting was 100, all of which is of one class and all holders thereof were entitled to vote on the above amendment; the number of such outstanding shares represented in person or by proxy at such shareholders' meeting was 100, a quorum.

(e) The number of shares voting for the adoption of this first amendment to the Articles of Incorporation at such shareholders' meeting was 100, the number of shares voting against adoption of such amendment was zero (0), and the number of shares abstaining was zero (0).
