The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is The Twentieth Hole, Inc. (hereafter "Corporation").

ARTICLE II

The purpose for which this Corporation is organized is as follows:

 To engage in any lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.
