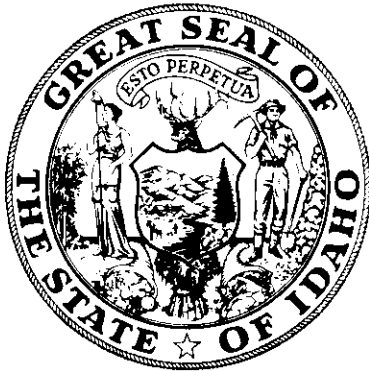

ARTICLES OF INCORPORATION

OF

KRISTIN CONCEPTS, LTD.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is KRISTIN CONCEPTS, LTD.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1,000) shares having a par value of TEN DOLLARS (\$10.00) per share, and an aggregate par value of TEN THOUSAND DOLLARS (\$10,000).

FIFTH: The address of the initial registered office of the corporation is Suite 303 Bollinger Plaza, 3rd and D Streets, Lewiston, Idaho, 83501, and the name of its initial registered agent at such address is John H. Bengtson.


