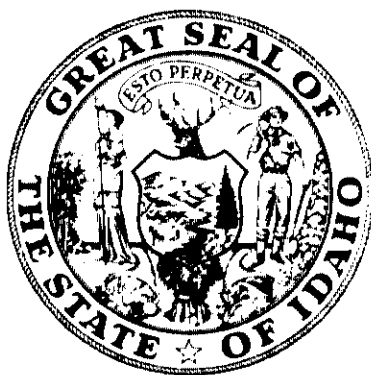

Pursuant to Section 30-1-61 of the Idaho Code of the Idaho Business Corporations Act, the undersigned corporation adopts the following Amendment to its Articles of Incorporation:

1. The name of the corporation is PAYETTE HEALTH CARE, INC.

2. The following amendment to the Articles of Incorporation was adopted by the Members of PAYETTE HEALTH CARE, INC. on the 15th day of March, 1988, in the manner prescribed by the laws of the State of Idaho.


