ARTICLES OF INCORPORATION

OF

BOUNDARY COUNTY FIRE AND EMERGENCY SERVICES COUNCIL, INC.

The undersigned, as incorporators of a non-profit corporation under the provisions of Idaho Code Section 30-301 et seq., adopts the following Articles of Incorporation for such corporation:

I.

NAME

The name of the corporation is BOUNDARY COUNTY FIRE AND EMERGENCY SERVICES COUNCIL, INC.

II.

DURATION

The period of its duration is perpetual.

III.

PURPOSES

This corporation is organized for the following purposes:

(a) To foster cooperation between all agencies operating in Boundary County for the purposes of providing fire protection services or other emergency services and to receive, administer, and expend funds for such purpose. Such cooperation may include but not be limited to mutual aid agreements, joint purchasing negotiation, equipment exchanges or purchases, information exchange, training, area coverage agreements, and law enforcement and government agency liaison.

(b) To engage in any non-profit activity that may lawfully be undertaken by a corporation organized under Idaho Code Section 30-301, et seq.

(c) To engage in all such activities as are incidental or conducive to the attainment of the purposes of this corporation, and to do such acts and things and to exercise any and all powers authorized or permitted to be done by a corporation under any laws that may be now or hereafter applicable or available to this corporation.

IV.

BYLAWS

The Board of Directors shall have the power to adopt, amend, or repeal the bylaws of this corporation.

V.

FUNDS AND ASSETS

This corporation shall use its funds only to accomplish the purposes stated in these articles, and no part of the funds of this corporation shall inure to the benefit of or be distributed to members of this corporation. In the event this corporation is dissolved, any net assets remaining shall be distributed to one or more regularly organized and qualified, charitable, educational, scientific or philanthropic organizations including local fire associations and emergency service associations selected by the Board of Directors, unless otherwise directed by law.

VI.

AMENDMENTS

These Articles may be amended by majority vote to the Board of Directors at an Annual or Special Meeting of the Board of Directors.

VII,

REGISTERED OFFICE, AGENT

The address of the initial registered office of this corporation is St. Rt. 2, Box 189A, Bonners Ferry, Idaho, 83805, and the name of its initial registered agent at such address is Wayne A. Fox.

VIII.
