

ARTICLES OF INCORPORATION OF

ARTICLE I CORPORATE NAME

The name of this corporation shall be:

CRAIG'S APPLIANCE REPAIR AND INSTALLATION, INC.

ARTICLE II EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III PURPOSES

ARTICLE IV CAPITALIZATION

Each share of stock shall be entitled to one vote in all matters wherein the shareholders of the corporation shall be entitled to vote, and each share shall, in all respects, be equal to every other share.

All restrictions relative to the transfer of shares of stock of the corporation shall be specifically noted on the stock certificates issued by the corporation.

3. For any transaction from which the director or officer derived an improper personal benefit.
