OF

The undersigned, being a natural person of at least 18 years of age and acting as the incorporator of the Corporation hereby being formed under the laws of Idaho, does hereby certify that:

1. The name of the Corporation is:

ED'S OFFICE PRODUCTS, INC.

2. The Corporation is formed for the following purposes:

To conduct the business of office supplies in every aspect and to enter into, perform and carry out contracts and agreements of every kind and nature, with any person, firm, corporation or other entity, and any State, county, municipal or other governmental body, including all boards, bureaus and agencies thereof.

To carry on any other activities necessary to, in connection with or incidental to the foregoing.

The provisions of this Article shall be construed as purposes and objects, and the matters expressed in each provision hereof shall not be limited in any way, except as otherwise expressly provided herein, by reference to or inference from the terms of any other provision hereof, and shall be regarded as independent purposes and objects. The enumeration of specified purposes and objects shall not be construed to exclude, limit or otherwise restrict in any manner any power, right or privilege given to the Corporation herein or by law, or to limit or restrict in any manner the meaning of the provisions hereof, or the general powers of the Corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature, not expressed.

3. The street address of the registered office of the Corporation in the State of Idaho is 41 South 150 East, Burley, Idaho 83318, and the name of the Corporation's initial registered agent upon whom process against the Corporation may be served at said registered office is GLORIA STRUCHEN.

4. The total number of shares of stock which the Corporation shall have authority to issue is 10,000 shares, no par value, all of which shall be of the same class and all of which are designated as common stock.

5. The number of directors constituting the initial Board of Directors of the Corporation is one. The number of directors of the Corporation may be increased or decreased pursuant to the bylaws of the Corporation, and so long as there are less than three shareholders, the number of directors may be less than three but not less than the number of shareholders.


