ARTICLES OF INCORPORATION  
OF

KNOWN ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of Incorporation for such corporation.

I
