

AMENDMENT TO ARTICLES OF INCORPORATION

The undersigned, being the President and Secretary of that certain corporation known as "DUMAS SEED COMPANY", do hereby amend ARTICLE VII of said Articles of Incorporation to read as follows:

ARTICLE VII: The amount of the capital stock of this corporation shall be Four Hundred Fifty Thousand Dollars (\$450,000.00) divided into two classes of shares, as follows:

4000 shares of common stock of the par value of \$100.00 each, and

500 shares of 6 1/2% preferred stock of the par value of \$100.00 each,

payable in property or cash at the time of issuance, and callable at any time by the corporation, the call price to be \$105.00.

The paid-in capital shall be at least \$1,000.00 before the corporation shall begin business.

The foregoing Amendment to the Articles of Incorporation was adopted by unanimous vote of the stockholders representing 1967 shares of the outstanding stock of the corporation at a special meeting called for the purpose of amending the Articles of Incorporation.
