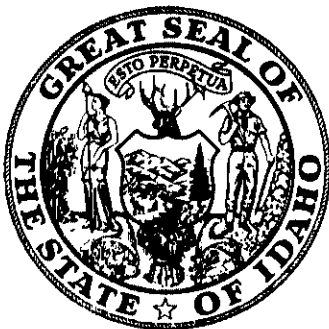
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation shall be Sims Studios, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized for the purpose of photography and further for the purpose of engaging in all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares with a no par value.

FIFTH: The transfer of the shares of the corporation is restricted and such restriction is specified in the bylaws of the corporation.
