ARTICLES OF INCORPORATION

The undersigned persons, acting as incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is:

ARTICLE II

PURPOSES AND POWERS

ARTICLE VI

LIMITATION ON LIABILITY

Within the meaning of and in accordance with Section 30-1-202(d) of the Idaho Code:

- (1) No director of the Corporation shall be personally liable to the Corporation or its shareholders for monetary damages for any action taken or any failure to take any action as a director, except as provided in this Article VI.
- (2) The limitation of liability contemplated in this Article VI shall not extend to (a) the amount of a financial benefit received by a director to which he or she is not entitled, (b) an intentional infliction of harm on the Corporation or its shareholders, (c) a violation of Section 30-1-833 of the Idaho Code, or (d) an intentional violation of criminal law.
- (3) Any repeal or modification of this Article VI by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
- (4) Without limitation, this Article VI shall be applied and interpreted, and shall be deemed to incorporate, any provision of the Idaho Code, as the same exists or may hereafter be amended, as well as any applicable interpretation of Idaho law, so that personal liability of the directors and officers to the Corporation or its shareholders, or to any third person, shall be eliminated or limited to the fullest extent as from time to time permitted by Idaho law.
