AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Post Falls,** in the County of **Kootenai,** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
OF  
HAUSER FAITH, BIBLE CHURCH, INC.

We, the undersigned, being natural persons over the age of twenty-one years, and residents of Kootenai County, Idaho, and citizens of the United States of American, and members of the Hauser Faith, Bible Church, Route 1, Post Falls, Idaho, in accordance with the discipline of the Hauser Faith, Bible Church, for the purpose of doing all acts which are required by said discipline and the usages of said church to be done and performed by the trustees of the said church, desiring to incorporate such church and to form ourselves into a corporation and body politic under the laws of the State of Idaho, for the use and benefit of said Hauser Faith, Bible Church, Route 1, Post Falls, Kootenai County, Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under Chapter 11, Title 30, of the Idaho Code, entitled "Religious Societies and Benevolent Corporations," and adopted the following Articles of Incorporation:

ARTICLE I.

The name of the corporation shall be HAUSER FAITH, BIBLE CHURCH, INCORPORATED.

ARTICLE II.

The object, business and purpose of this corporation is non-political, and shall be devoted to promoting a spirit of Christian brotherhood and teaching of the Bible, and to uphold and maintain the Constitution of the United States of America and all the subdivisions thereunder, and to assist in the maintaining of law and order; to safeguard

and transmit to posterity the purity and righteousness of individual freedom; to assist in charitable work of any nature deemed beneficial and to the best interests of the order and to society as a whole, and to raise funds for carrying the same into effect in any manner allowed by the constitution and by-laws of the order, and permitted under the laws of the State of Idaho and the Constitution of the United States of America.

#### ARTICLE III.

The existence of this corporation shall be perpetual.

#### ARTICLE IV.

The registered office and place at which the principal business of this corporation shall be conducted and transacted shall be located at Route 1, Post Falls, Kootenai County, State of Idaho.

#### ARTICLE V.

This corporation shall have no capital stock. The terms of admission to membership in the corporation shall be as prescribed by the Board of Trustees and Directors.

#### ARTICLE VI.

Pursuant to Section 30-1102, Idaho Code Annotated, an election of directors of this corporation was held on the 8th day of October, 1966, at 8:00 o'clock p.m. at the home of Marion P. Brownlee, Hauser Lake, Route 1, Post Falls, Idaho, at which election a majority of the members were present and voted.

By majority vote, the following were elected as Directors of this organization:

C. E. SIMPSON, Route 1, Post Falls, Idaho  
M. P. BROWNLEE, Route 1, Rathdrum, Idaho  
J. L. SOWERS, Route 1, Post Falls, Idaho.

That notice of the time and place of holding such election was given by publication in the Coeur d'Alene Press, Coeur d'Alene, Kootenai County, Idaho, which publications were made on September 22nd and September 29th, 1966. A true copy of said notice was further posted in a conspicuous place on the building wherein said election was held for two successive weeks prior to the election.

ARTICLE VII.

All of the incorporators and directors subscribing hereto are of full age and all of them are citizens of the United States of America.
