KNOW ALL MEN BY THESE PRESENTS, that we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a limited corporation under the laws of the State of Idaho;

And we do hereby certify:

, 1st.

That the name of said corporation is CONSTITUTION MINING COMPANY, LIMITED.

2nd.

That the purposes for which this corporation is formed are to own and control, purchase and develop, sell and convey quartz mines and quartz mining claims in the State of Idaho and to operate the same, including the construction of mills, wagon roads, flumes, ditches, hoisting and reduction works, and everything necessary for the successful development and operation of the same, and particularly to purchase, develop, improve, and operate the "Montana" mine on Estes Mountain, in Custer County, Idaho, and other contiguous mining properties and mines in the vicinity thereof.

, 3d.

That the place where its principal business is to be transacted shall be Boise City, Ada County, Idaho.

4th.

That the term for which said corporation is to exist is fifty years from and after the date hereof.


