One Thousand Nine Hundred Forty-four and is duly recorded No. 3 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

KNOW ALL MEN BY THESE PRESENTS: That we, whose names are hereby affixed, and all of whom have been duly elected directors of the Church of the Nazarene of Coeur 'Alene in accordance with its rules, regulations and by-laws, do under and in pursuance of Section 29, Chapter 11, of the Idaho Code Annotated as amended, and the general corporation laws of said State hereby organize; constitute and associate ourselves and such other persons as may hereafter become associated with us, in accordance with these Articles, into a body politic and corporate, for the purposes hereinafter set forth, but not for pecuniary profit or advantage, and to that end we execute these Articles of Incorporation, and hereby certify, set forth and declare as follows:

I.

NAME.

The name of this corporation is and shall be "CHURCH OF THE NAZARENE, INC." COEUR D'ALENE.

II

OBJECTS AND PURPOSES

The general purpose and plan of operation of this corporation shall be to establish a Church of the Nazarene in Coeur d'Alene, Idaho, to buy, manage, and own and hold real and personal property necessary and proper for a place of public worship, school and parish house, carry on educational and charitable work, under rules and regulations of a constitution to be adopted by the congregation of the above named church, said constitution to be in harmony with these articles of incorporation and the laws of the State of Idaho.

III.

PLACE OF BUSINESS

That the place where the principal business of this Corporation shall be transacted, and the registered Post Office of said Corporation, is and shall be Coeur d'Alene, Idaho.

CORPORATE EXISTENCE

The corporate existence of this Corporation shall be perpetual.

٧.

MEMBERSHIP

There shall be no capital stock of this Corporation, but all members of the Church of the Nazarene of Kootenai County, Idaho, shall by virtue of such membership be members of this Corporation.

VI.

DIRECTORS

The corporate powers of this corporation shall be vested in a Board of four (4) Directors, to be elected as provided in the By-laws of this Corporation. To be a Director, a member must be in good standing of the Church of the Nazarene of Coeur d'Alene, Inc.

The powers and duties of the officers of this Corporationa shall be prescribed in the by-laws.
