## ARTICLES OF INCORPORATION OF PLUMMER CELEBRATIONS, INC.

The undersigned incorporators, desiring to form a Corporation pursuant to the provisions of the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation:

### ARTICLE ONE:

Name: The name of the Corporation is **Plummer Celebrations, Inc.**, whose physical office is located at 888 C. Street, Plummer, Idaho 83851. The mailing address for the Corporation is in care of Kathleen Miller Green, 485 First Street, Plummer, Idaho 83851.

### ARTICLE TWO:

Registered Office and Registered Agent: The name of the registered agent of the Corporation is Bessie Houck. The street address of the registered agent is 175 Sixth Street, Plummer, Idaho 83851.

### ARTICLE THREE:

Duration: The period of duration of this non-profit corporation is perpetual.

### ARTICLE FOUR:

Type of Corporation: The Corporation is a non-profit corporation organized for and as a mutual benefit corporation.

## ARTICLE FIVE:

Authorization: The Corporation is authorized under Idaho Non-Profit Corporation Act, this being Title 30, Chapter 3 of the Idaho Code.

## ARTICLE SIX:

Purposes: The purposes for which this Corporation is organized are to promote the betterment and best interests of the City of Plummer, Benewah County, Idaho, and of the Plummer Idaho community; to sponsor, promote, and promulgate events, public gatherings and celebrations dedicated to this general purpose, and for the recreation, enjoyment, and of citizens and visitors to the Plummer, Idaho area; to represent, protect and advance the social economic and educational and historical interests of the Plummer community, its residents and visitors; to correlate the activities, and cooperate with other individuals, governmental entities, and groups located at or in vicinity of the Plummer, Idaho area; and to promote a mutually beneficial organization with such persons, groups, government entities, schools, and businesses in the Plummer, Idaho area; and to advertise the events and celebrations sponsored by or contributed to by the Corporation and, in general, to do and perform acts and transact business in connection with the foregoing objects and purposes consistent with the general laws of the United States of America, the State of Idaho, or any local laws or ordinances, in effect in the Plummer, Idaho area.

## ARTICLE SEVEN:

Non-stock Corporation: The Corporation is a non-stock and no dividends or pecuniary benefits will be declared or paid to the members of the Corporation.

#### ARTICLE ELEVEN:





The Corporation will not have members, it will be governed and controlled by its directors and officers pursuant to the provisions of corporate by-laws.
