ARTICLES OF INCORPORATION

Articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desire to form a Non-Profit Corporation under the Non-Profit Corporate Law of the State of Idaho, do hereby certify:

ARTICLE I

CONSTITUTION

The name of this corporation shall be CHURCH ON THE ROCK INTERNATIONAL, INC. OF THE CITY OF BOISE, STATE OF IDAHO, ADA COUNTY

ARTICLE II-PURPOSE

The purpose of this church shall be:

- A. To establish and maintain a place of worship
- B. To conduct under the guidance of the Holy Scriptures the work of evangelizing both home and foreign field in obedience to the command of the Lord Jesus and His apostles.
- c. In connection therewith, or incidental thereto, it shall have the right to purchase or acquire by gift, bequest, or otherwise, either directly or as a trustee, and to own, hold in trust, use sell, convey, mortgage, lease, or otherwise dispose of any real estate or chattels as may be necessary for the furtherance of its purposes.


ARTICLE V - DISTRIBUTION OF ASSETS


