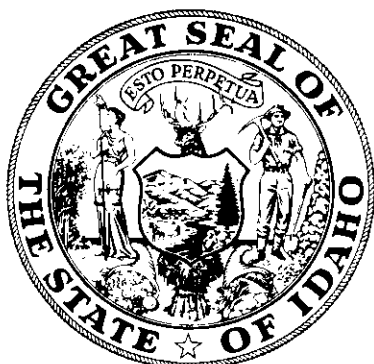

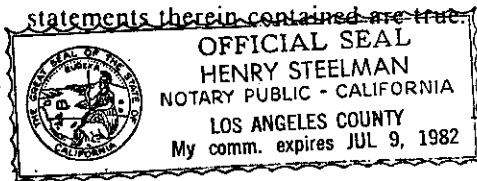

ARTICLES OF INCORPORATION

OF

ONE: The name of this corporation is A, A & A ORIENTAL RUGS, INC.

TWO: The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than banking business, the trust company or the practice of a profession permitted to be incorporated by the California Corporations Code.
