CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

KETCHUM-SUN VALLEY ROD AND GUN CLUB, INC.

was filed in the office of the Secretary of State on the **First** day of **March** A. D. One Thousand Nine Hundred **Sixty-three** and is duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Ketchum** in the County of **Blaine** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF

KETCHUM-SUN VALLEY ROD AND GUN CLUB, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned citizens of the United States of America and residents of Blaine County, Idaho, being all of full age and not in any way disqualified, do by these presents associate ourselves together for the purpose of forming a corporation in which the pecuniary profit of members is not a purpose; and we do hereby certify as follows:

ARTICLE I

That the name of said corporation shall be KETCHUM-SUN VALLEY ROD AND GUN CLUB, INC.

ARTICLE II

That the registered office of the corporation shall be located at Ketchum, Idaho; and the post office address thereof shall be Ketchum, Idaho.

ARTICLE III

That the corporation shall have perpetual existence.

ARTICLE IV

That the corporation is formed for the purposes hereinafter specified but not for pecuniary profit of its members.

ARTICLE V

That the purposes of the corporation are as follows:

A. TO PARTICIPATE IN, TO PRODUCE, AND/OR sponsor, either alone or in association with any other person, group or organization, any or all worthwhile measures for conservation of fish and wildlife in the State of Idaho; any or all measures for promotion of firearms proficiency and safety; any or all worthwhile civic projects including but not limited to exhibitions, processions, parades, dances, beauty and talent contests, horse races of various kinds, and other exhibitions of horsemanship, all types of western entertainment, athletic contests and games; and to provide, serve or arrange for refreshments and

food for consumption in connection with any purpose of the corporation.

B. TO UNDERTAKE, either alone or in conjunction with any other person, group or organization, any commercial enterprise for the promotion of the purposes of this corporation.

C. TO PROMOTE AND FOSTER good fellowship among the members and to promote the growth, pride, and stability of the corporation.

D. To promote and teach the arts and skills of firearm handling, including rifles, shotguns, handguns, and to teach proper safety of gun handling.

E. To own or acquire real and personal property and all kinds of interests therein as may be useful or convenient in carrying out any of the abovementioned purposes, and to sell, encumber or in any manner dispose of the same.

F. To do each and every act and thing necessary or convenient to carry out any of the aforesaid purposes.

ARTICLE VI

That the number of directors of the corporation shall be five, to be elected annually in such manner as may be provided by the by-laws.

ARTICLE VII

That there shall be no capital stock but that the corporation shall issue certificates of membership to each member, which certificates may not be assigned in such manner that the transferee thereof can by such transfer become a member of the corporation, except by resolution of the Board of Directors and under such regulations as the by-laws may prescribe. The by-laws may provide for the number and qualifications of members, the conditions of admission and expulsion and all other matters allowed by law, The rights and interests of all members are equal.

ARTICLE VIII

That the names and places of residence of the original incorporators are as follows:

ARTICLE IX

That the officers of the corporation shall be President, Vice-President, Secretary and Treasurer. The offices of Secretary and Treasurer may be combined. The officers shall be elected by the Board of Directors and the Board of Directors shall be elected by the members. Until the first election by the members, the original incorporators above named shall constitute the Board of Directors.

ARTICLE X

The members of this corporation shall not be liable for the obligations of the corporation.

ARTICLE XI

The by-laws shall be adopted by the Board of Directors and may be repealed or amended by them. Vacancies on the Board of Directors may be filled by the remaining directors.
