## ARTICLES OF INCORPORATION

of

## OROFINO BOXING CLUB, Incorporated

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of the laws of the State of Idaho, for the purpose expressed in ARTICLE II hereof, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I.

The name of this corporation shall be OROFINO BOXING CLUB, INCORPORATED.

## ARTICLE II.

The objects of this corporation are:

- A. To promote the sport of boxing in the Clearwater County area for the youth and provide any and all healthful youth and sport activities.
- B. Any other lawful purposes and power in keeping with the nature of this corporation and permitted by Idaho law.

#### ARTICLE III.

The duration of this corporation shall be perpetual.

#### ARTICLE IV.

This corporation shall be a non-profit corporation having one class of members whose membership shall be evidenced by a membership card. Membership shall be open to all youth and adults of Clearwater County, Idaho and Peck, Idaho areas upon payment of such membership fees and dues as set forth in the by-laws of this corporation. Each person holding membership shall be entitled to one vote.

#### ARTICLE V.

The location of the corporation's registered office
