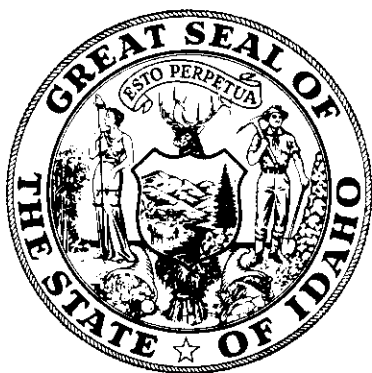

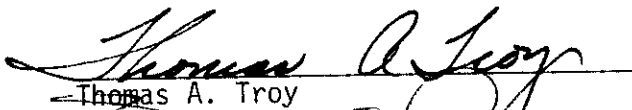

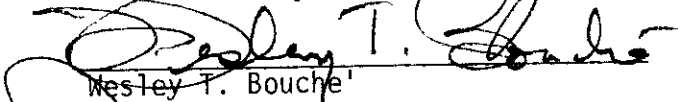

the hour of 10:00 a.m., on the 15th day of April, 1983.

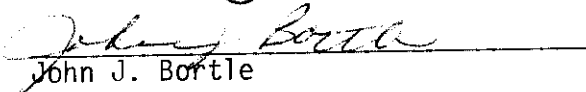
