


CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

THIS IS TO CERTIFY that we, the undersigned, hereby incorporate pursuant to the Laws of the State of <u>IDAHO</u> providing for the formation of corporations for profit, for the purposes and with the powers hereinafter stated.

Ι

The name of this corporation is:

II

The general nature and purpose of the business of this corporation shall be the operation of a retail service station dealership and the performance of any and all activities generally associated thereto; and also

To engage in any activity of business permitted under the Laws of the United States and of this State.

The existence of this corporation is to be perpetual.
