That we, the undersigned, being of full age and citizens of the United States, do this day voluntarily form a corporation under the provisions of the Idaho Nonprofit Corporation Act, and we certify in writing:

- 1. NAME. The name of the corporation shall be Idaho Chapter of the National Tooling & Machining Association, Inc.
- 2. NONPROFIT. This corporation is a nonprofit corporation.
- 3. PURPOSE AND POWERS. The purpose of this Corporation is to promote, by any lawful means, the welfare of its members and the general development and improvements of the tooling and machining industry; and, in doing so, to originate, promote or take part in any lawful movement or enterprise which, in the judgment of the Board of Directors of the Corporation, will tend to preserve and promote the best interests of the citizens of the United States of America, the American system of free enterprise and the persons, firms and corporations interested in the tooling and machining industry.
- 4. MEMBERS. This corporation shall have members. Management of its affairs shall be vested in this Corporation's duly elected Board of Directors.
- 5. DURATION. Subject to dissolution in the manner provided by law, the corporation shall be perpetual.






