ARTICLES OF INCORPORATION

OF

CASTLE CREEK IRRIGATION COMPANY

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned John L. Ellwsorth, Lewis Maupin, and Joseph Merrick, each being a Matural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify, declare and adopt the following articles of incorporation:

I

The name of this corporation shall be CASTLE CREEK IRRIGATION COMPANY.

II

The period of existence and duration of the life of this corporation shall be perpetual.

III

The location of the registered office of this corporation shall be Oreana, County of Owyhee, State of Idaho, and the address of the registered office of this corporation shall be Oreana, Idaho 83659.

The address is Oreana Star Rt, Murphy, Idaho The agent is John L. Elleworth 836:

The nature of the business and the objects and purposes of this corporation shall be:

To construct, or otherwise acquire, maintain, manage, operate, and control an irrigation system, and to furnish domestic, stock and irrigation water therefrom to the shareholders of the corporation, exclusively, on land in the State of Idaho; and to do any act or thing necessary or convenient connected therewith for the purposes herein set forth or ancillary or related thereto; to acquire, own, rent, lease, mortgage, and dispose of all kinds of real and personal property; to establish rules and regulations for the use and distribution of water from the irrigation system aforesaid; and to levy and collect for its purposes tolls and assessments from its shareholders.

In general, this corporation shall have the power and authority to carry on any other business in connection with any of the foregoing, and to have and exercise all the powers conferred by the laws of the State of Idaho upon corporations.

v

In furtherance, and not in limitation of the powers conferred by stature, the board of directors is expressly authorized:

To make and alter by-laws of this corporation, to fix the amount to be reserved as working capital over and above its capital stock paid in, and to authorize and cause to be executed mortgages and liens upon the real and personal property of this corporation.

If the by-laws so provide, to designate two or more of its members to constitute an executive committee, which committee shall for the time being, as provided in said resolution or in the by-laws of this corporation, have and exercise any or all of the powers of the board of directors in the management of the business and affairs of this corporation, and have power to authorize the seal of this corporation to be affixed to all papers which may require it.

Pursuant to the affirmative vote of the holders of at least a majority of the stock issued and outstanding, having voting power, given at a stockholders' meeting duly called for that purpose, or when authorized by the written consent of at least a majority of the holders of the voting stock issued and outstanding, the board of directors shall have power and authority at any meeting to sell, lease or exchange all of the property and assets of this corporation, including its good will and its corporate franchises, upon such terms and conditions as its board of directors deem expedient and for the best interest of the corporation.

This corporation may in its by-laws confer powers upon its directors in addition to the foregoing, and in addition to the powers and authorities expressly conferred upon them by statute.

The capital stock of this corporation shall be One Thousand Dollars (\$1,000.00) divided into one thousand (1,000) shares of stock of the par value of One Dollar (\$1.00) each. The shares of this corporation shall be subject to assessment only for construction, operation and maintenance of its irrigation system or for administrative expenses of the operation.

VII

All or any portion of the capital stock may be issued for cash or in payment for real or personal property, services, or any other rights or thing of value, for the uses and purposes of the corporation, and when so issued shall become and be fully paid, the same be the sole judges of the value of any property, right or thing acquired in exchange for capital stock.

VIII

From time to time the capital stock may be increased according to law, and may be issued in such amounts and proportions as shall be determined by the board of directors, and as may be permitted by law.

IX

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatsoever.

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these articles of incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon stockholders herein are granted, subject to this reservation.

XI

This corporation is organized and shall be operated exclusively as a mutual or cooperative organization within the provisions of Section 501 (c) (12) of the 1954 Internal Revenue Code. Notwithstanding any other provisions of these Articles, this corporation shall not exercise any powers or engage in any activities not permitted to an organization which is exempt from federal income tax under Section 501 (c) (12) of the 1954 Internal Revenue Code. Shareholders shall have the right to receive services substantially at cost and shall have the right to receive a return of any excess of payments over losses and expenses not required for establishment of necessary reserves, and to share in any assets pro rata upon dissolution. Excess income, if any, not retained

in reasonable reserves for future losses and expenses, belongs to the shareholders in proportion to their patronage or business done with the corporation, provided, however, that the corporation is forbidden to conduct any business with the shareholders except delivery of water in accordance with the by-laws of the corporation and the laws of the State of Idaho. It is not intended that the corporation shall do business on a profit-making basis, however, if there is an excess of income over expenses which results in patronage refunds to be retained in reasonable amounts for purposes of expanding facilities, retiring capital indebtedness and acquiring other assets, the corporation will maintain records sufficient to reflect the equity of each member in the assets acquired with the funds. Stock in the corporation shall be issued only to persons or entities who own or are acquiring lands to which irrigation water is or can be delivered by any irrigation system owned, operated or managed by the corporation and who are, therefore, doing business with the corporation in that manner and to that extent.

WE, THE UNDERSIGNED, being each one of the original subscribers to the capital stock hereinbefore named for the purposes for forming a corporation to do business both within and without the State of Idaho, and in pursuance of the laws of the State of Idaho, do make and file these articles of incorporation, hereby declaring and certifying that the facts herein stated are true, and we respectively agree to take the number of shares of stock hereinbefore set opposite our names and accordingly have hereunto set our hands and seals this _____ day of
