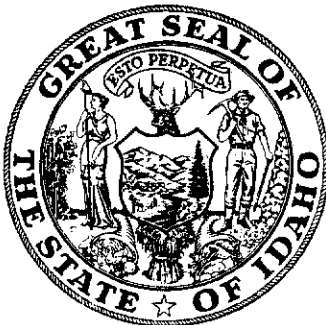
CERTIFICATE OF AMENDMENT OF
