LIMITED POWER OF ATTORNEY

- 1. To exercise or perform any act, power, duty, right or obligation whatsoever that he now has, or may hereafter acquire the legal right, power or capacity to exercise or perform, in connection with, arising from, or relating to the Agreement to Withdraw as General Partner of Northside Court Limited Partnership, an Idaho Limited Partnership, to complete any and all agreements, to complete any and all documents necessary to complete any and all projects associated with Northside Court Limited Partnership from the date of this Limited Power of Attorney to December 1, 2009.
- 2. Granting to said attorney-in-fact, Dianne Hunt, full power and authority to do, take, and perform all and every act and thing whatsoever requisite, proper or necessary to be done in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes as they might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that said attorney-in-fact shall lawfully do or cause to be done by virtue of this power of attorney and the rights and powers herein granted.
- 3. This instrument is to be construed and interpreted as a limited power of attorney. The enumeration of specific items, rights, acts or powers herein is intended to and does limit and/or restrict, and is to be construed and interpreted as limiting or restricting the powers herein granted to said attorney-in-fact, Dianne Hunt. In the event that Dianne Hunt in anyway exceeds the authority granted in this Limited Power of Attorney, she will be personally liable for any claim resulting therefrom and will defend, hold harmless, and indemnify William Ward for any such claim.

- 4. This Limited Power of Attorney shall not be affected by any subsequent disability or incapacity of the undersigned principal.
- 5. The rights, powers and authority of said attorney-in-fact herein granted shall be in full force and effect on the date of the execution hereof, and such rights, powers and authority shall remain in full force and effect thereafter until the death of the undersigned, or until revoked in writing by him, or December 1, 2009, whichever occurs first.
