OF
S2 INDUSTRIAL, INC.



The undersigned natural person of the age of twenty-one (21) years, or more, acting as incorporator under the Oregon Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation is S2 INDUSTRIAL, INC., and its duration shall be perpetual.

ARTICLE II
