
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

WESTOM CORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I

The name of the corporation shall be **WESTOM CORPORATION**.

Article II

The period of its duration is perpetual.

Article III

The purpose or purposes for which the corporation is organized are: to carry on the business of potato processing and any lawful activity related to such business, and the transaction of any or all other lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

Article IV

The aggregate number of shares which the corporation shall have authority to issue is 500 with par value of \$1.00 per share.

Article V

There are no provisions denying preemptive rights.

Article VI

The mailing address of the initial office of the corporation is P. O. Box 66, Hammett, Idaho 83624. The name of its initial registered agent at such address is Weston D. Farris. The physical address of the registered agent is Sunrise Farms, Glens Ferry, Idaho 82623.

Article VII


