## ARTICLES OF INCORPORATION

OF

## INSPECTION & TESTING, INC.

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

#### ARTICLE I

The name of the corporation shall be Insepction & Testing, Inc.

### ARTICLE II

The purposes for which said corporation is formed are:

- A. Materials inspection and testing including but not limited to the testing of concerete, steel, pipeline, and commercial building materials
- B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### ARTICLE III

The Corporation is to have perpetual existence.
