ROBERT G. SQUIRE and JUDITH M. SQUIRE certify:

1. That they are the President and the Secretary respectively, of SQUIRE AIRCRAFT, INC., a Idaho Corporation.
2. That at a meeting of the Shareholders of said corporation, duly held at Buhl, Idaho, on November 11, 1992, the following resolutions were adopted:

"RESOLVED: that the Articles of Incorporation of this corporation be amended to include two new Articles VII and VIII, and they shall read as follows:

VII

The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under Idaho Law.

VIII

The corporation is authorized to provide indemnification of agents for breach of duty to the corporation and its stockholders through bylaw provisions or through agreements with the agents, or both, in excess of the indemnification otherwise permitted by the Idaho Corporations Code, subject to the limits on such excess indemnification set forth in the Idaho Corporations Code."


3. That the Board of Directors have adopted said amendment by resolution at a meeting held in Buhl, Idaho on November 11, 1992. That the wording of the amended articles, as set forth in the Board of Directors' resolution, is the same as that set forth in the Shareholders' resolution in paragraph 2 above.

4. That the number of shares which voted affirmatively for the adoption of said resolution is 100, and that the total number of shares entitled to vote on or consent to the said amendment is 100.
