

ARTICLES OF INCORPORATION.  
WEST SIDE LATERAL COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS; - That we, the undersigned, have voluntarily associated ourselves together for the purpose of organizing a private corporation under and by virtue of the laws of the State of Idaho, and for this purpose we do hereby set forth and declare as follows:

FIRST.

The name of this corporation is and shall be, WEST SIDE LATERAL COMPANY, LIMITED.

SECOND.

That the place where the principal business of this corporation shall be transacted is Payette, in the County of Canyon, State of Idaho.

THIRD.

That the term for which this organization shall exist is fifty years.

FOURTH.

That the purposes for which this organization is formed are, acquiring, owning and holding a Lateral and the branches thereof, as the same are now established, which lateral takes water out of the Canal of the Farmers Co-operative Irrigation Company, Limited, in Section Three, Township Seven North, of Range Five West of the Boise Meridian, in the County of Canyon, State of Idaho, including all rights of way and all appurtenances thereunto belonging, acquiring, owning and holding such other rights of way and laterals as may be found necessary in carrying into effect the purposes herein expressed, owning and holding such other real and personal property as may be required for the use of said corporation in conducting the business thereof; maintaining and operating such property for the purpose of supplying water for irrigation and domestic uses, to the stockholders of this corporation at the actual cost of maintaining such property and delivering the water to the consumers thereof, and the doing and performing of all such other acts and things as may be essential to the full and complete carrying out of the purposes above set forth.

That the number of Directors of this corporation shall be five, and the names and residences of those who are appointed as Directors for the first year of the life of this corporation are as follows:-
